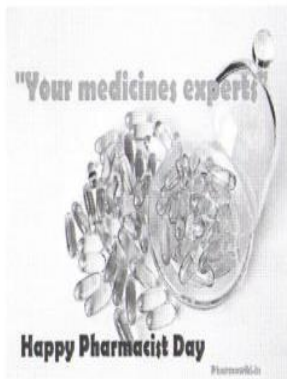

What is TB?
Tuberculosis is a potentially fatal contagious disease that can affect almost any part of the body but is mainly an infection of the lungs.

What causes TB?

- TB is caused by mycobacterium tuberculosis
- By air droplets (coughing and sneezing)
- By close contact with an infected person.

Risk factors

- Malnutrition
- Excessive alcohol addiction
- Immunosuppressive patients
- Poor health, children below 5 yes
- Smoking
- Drug abuse














Signs and symptoms

- Persistent cough
- Chest pain
- Coughing with bloody sputum
- Shortness of breath
- Urine discolouration
- Fever with chills
- Fatigue
- Loss of appetite / weight loss

Suspect TB if:

- Unexplained weight loss, decreased appetite, night sweats, fever, fatigue.
- Coughing > 3 weeks ,chest pain

Diagnosis:
Mantoux test : The mantoux test is the standard method of determining whether a person is infected with mycobacterium tuberculosis.

The local skin reaction to tuberculin purified protein derivative (ppd) injected into the skin is used to assess the individuals sensitivity to tuberculin protein.

Other diagnostic tests:

- Physical examination
- Chest radiography
- Sputum culture
- Acid fast bacillus smear
- DNA based detection

How is it treated?

Tuberculosis is curable and preventable . active TB is treated with a standard 6 month course of 4 antimicrobial drugs i.e

- RIFAMPIN
- ISONIAZID
- ETHAMBUTAL
- PYRAZINAMIDE



TB VACCINE:

- BCG VACCINE: Bacillus calmette Guerin (BCG) vaccine is primarily used against tuberculosis.
- It is a live attenuated bacterial vaccine derived from M. Bovis
- BCG vaccine reduces the risk of tuberculosis in people who are not infected with tuberculosis.
- It is more effective in children < 6 year old, providing 50-80% protection against meningial and miliary TB.
- Protection against TB will only start 6 to 8 weeks after the vaccination has been given.



Revaccination is not recommended

How can tuberculosis prevented?

- Use personal respiratory protective devices.
- Avoid exposing yourself to people with active TB.
- Get the BCG vaccine for prevention.
- Don't smoke or drink alcohol.
- Schedule a TB test if you have been exposed to someone with TB.
- Ventilate the room.
- Early diagnosis and treatment .
- House should be adequately ventilated
