The benchmark for action was set at 60% or fewer 'Excellent' responses, enabling RBVRRWCP to identify areas warranting attention and improvement. Through this rigorous process, several key concerns were identified, shedding light on crucial aspects requiring intervention. Building upon these findings, recommendations for action have been thoughtfully suggested, aiming to address the identified concerns and foster continuous enhancement across various facets of RBVRR Women's College of Pharmacy.
