- The application should include details of the conference, workshop, or professional organization membership, along with supporting documentation, such as receipts or invoices.

Approval Process:

- Applications will be reviewed by the designated committee responsible for faculty development.
- The committee will assess the merit and relevance of each application based on established criteria.

Obligations of Faculty Members:

- Upon completion of the event or membership registration, faculty members must submit a report highlighting key learnings and outcomes to the designated authority.

Monitoring and Evaluation:

- The effectiveness of this policy will be periodically evaluated based on the participation rates of faculty members in professional development activities, particularly those receiving support above Rs. 5000 per year.
- Feedback from faculty members regarding the impact of financial support on their professional growth will be solicited and considered for policy refinement.
